Council Approves New Tax Rate and Homestead Exemption

At the September 17 City Council meeting, a new property tax rate of \$0.276204 per \$100 of value was approved for the upcoming year. This new rate, part of the City's 2025 budget, is needed to cover rising costs for public safety, inflation, and other essential services that keep our community running smoothly.

To help homeowners, the City also introduced a new 7% Homestead Exemption this year. This exemption lowers the taxable value of your home, meaning most homeowners will see a smaller tax bill than last year. For example, if your home is worth \$700,000, you will pay about \$29 less in property taxes compared to last year.

Your tax bill will show the full rate, but don't worry — the 7% homestead exemption will reduce the amount you actually pay. This means most homeowners will still pay less in taxes compared to last year, despite the new rate.

Special Saturday Collections for Leaf, Christmas Tree Recycling

Special leaf and Christmas tree recycling collections will return this winter. Community Waste Disposal (CWD), Colleyville's trash and recycling provider, will run special collection routes to recycle bagged leaves starting in November. This year's program includes five collection days; Saturdays, Nov. 23, Dec. 7, Dec. 14, Dec. 21, and Jan. 4 with collections beginning at 8:00 a.m. CWD will also collect and recycle Christmas trees on the January special collection day. Residents are asked to not enclose the tree in a plastic sack or bag and to remove all tinsel, stands, and tree decorations.

To participate, residents just need to set out leaves on the designated collection days. CWD will recycle leaves that are contained in either a paper lawn craft bag or a plastic bag. If leaf bags are set out prior to the Saturday collections, residents are asked to place leaf bags separately from household trash. Regular rear-load garbage trucks will be used for these special collection days. With that in mind, residents should be aware of and comply with their Homeowner Association's policies. FY2025-2029 Capital Improvement Plan Available Online

As part of the Fiscal Year 2025 budget process, the City Council recently adopted the FY 2025-2029 Capital Improvement Program. The CIP document can be found at Colleyville.com/CIP. In addition to the program document, the website also includes an interactive map that allows users to explore existing and planned projects in Colleyville to learn about the project status and funding sources. The map contains details for Capital Improvement Projects planned throughout the City relating to City facilities, parks and recreation, sidewalks and trails, streets, and drainage. While major projects often get most of the publicity, the map cites those and much smaller projects, with funding sources ranging from the city's budget to county and state grants.
