



PROCLAMATION #3

CLARIFYING IMPLEMENTATION OF COLLEYVILLE'S FIRST AMENDED DECLARATION OF DISASTER

WHEREAS, Governor Greg Abbott has issued a State of Disaster in response to the current COVID-19 pandemic; and

WHEREAS, the City Charter provides that the Mayor may administer the City's local declaration of emergency by proclamation; and

WHEREAS, in keeping with the Executive Orders issued by the Governor on May 5, 2020, I, Mayor Richard Newton, have determined that certain changes in the administration of the City of Colleyville's First Amended Declaration of Disaster dated March 24, 2020 ("Declaration") should be made to continue our collective efforts to preserve the health, safety and welfare of our community; and

WHEREAS, Proclamation #2 issued April 28, 2020 shall be repealed in its entirety and replaced with this Proclamation #3, effective 12:01 a.m., May 8, 2020.

NOW THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE CITY OF COLLEYVILLE, TEXAS THAT:

Effective 12:01 a.m., on Friday, May 8, 2020, the following **may resume** operations in conformance with the recommendations outlined in the Governor's Report to Open Texas (dated 4/27/20), as the same may be amended:

1. Religious services conducted in churches, congregations, and houses of worship are no longer prohibited by the Declaration.
2. Wedding services may be held indoors at a church, congregation, or house of worship following the recommendations outlined in Section 1 for "religious services"
3. Wedding reception venues that are not churches, congregations, or houses of worship may operate at up to 25 percent of the total listed occupancy of the facility; provided, however, that the occupancy limits do not apply to the outdoor areas of a wedding reception or to outdoor wedding receptions.

4. Elective surgery and other procedures not medically necessary to diagnose or correct a serious medical condition in compliance with Executive Orders GA-15 & GA-18.
5. Article I, Section 7 of the Declaration has been repealed in its entirety.
6. Article II, Section 3 of the Declaration has been repealed in its entirety.
7. Exhibit A of the Declaration (Disaster Restrictions) has been rescinded and replaced with the Governor's Report to Open Texas (dated 4/27/20). All recommendations outlined in the Governor's Report to Open Texas should be followed where applicable.
8. Restaurants that have less than 51 percent of their gross receipts from the sale of alcoholic beverages for service to customers so long as occupancy is limited to 25%. No occupancy limits are placed on outdoor patios.
9. "Re-opened" (non-essential) retail establishments allowing for in-store retail services so long as occupancy is limited to 25 percent.
10. Movie theater operations at up to 25 percent of the total listed occupancy of any individual theater for any screening.
11. Cosmetology salons, hair salons, barber shops, nail salons/shops, and other establishments where licensed cosmetologists or barbers practice their trade without limitation of occupancy; provided, however, that all such salons, shops, and establishments must ensure at least six feet of social distancing between operating work stations.
12. Tanning salons; provided, however, that all such salons must ensure at least six feet of social distancing between operating work stations.
13. Swimming pools; provided, however, that (1) indoor swimming pools may operate at up to 25 percent of the total listed occupancy of the pool facility; (ii) outdoor swimming pools may operate at up to 25 percent of normal operating limits as determined by the pool operator; and (iii) local public swimming pools may so operate only if permitted by the local government.


Effective 12:01 a.m., on Monday, May 18, 2020, the following **may resume** operations in conformance with the recommendations outlined in the Governor's Report to Open Texas (dated 4/27/20), as the same may be amended:

14. Services provided by office workers in offices that operate at up to the greater of (i) five individuals, or (ii) 25 percent of the total office workforce;

provided, however, that the individuals maintain appropriate social distancing.


15. Manufacturing services, for facilities that operate at up to 25 percent of the total listed occupancy of the facility.
16. Gyms and exercise facilities and classes that operate at up to 25 percent of the total listed occupancy of the gym or exercise facility; provided, however, that locker rooms and shower facilities must remain closed, but restrooms may open.
17. People shall avoid visiting bars and massage establishments (unless medically prescribed).
