New Year Brings Economic Success

The New Year has brought with it economic development success. The City will soon welcome LOOK Cinemas and HTeaO. LOOK Cinemas is in the process of moving into the former Studio Movie Grill space, backfilling a large space within Town Center Colleyville. The City has worked with LOOK Cinemas and the owner of the shopping center for the last several months on this economic development win for the City. LOOK Cinemas is a high quality operator that provides a full menu and bar and comfortable seating for patrons. The theater group has applied for occupancy and will make initial improvements inside to open by the spring/summer movie season.

HTeaO is a West Texas-based to-go tea concept that is looking to build on the old Sonic site next to Red Barn BBQ at Glade Road and SH26. This is a small, challenging site that the City has worked on with the owner for a couple of years with various tenants. HTeaO is excited to join the Colleyville community!

Colleyville will see additional retail space coming online this year at the southeast corner of SH26 and Longwood near Scooter's Coffee. A 10,000-square-foot retail building is planned for the site. Colleyville is doing well in terms of occupancy rates – office occupancy is at 90%, and retail is at 95.6%, both above national averages.



Clean Sweep Returns March 5 in New Location

Clean Sweep, our annual clean-up event, is scheduled for Saturday, March 5 at our NEW location – the south parking lot at Colleyville City Hall! Clean Sweep is a one-stop shop for residents to properly dispose of household hazardous waste, tires, brush, electronics, and paper, through five stations. The event runs from 9-11 a.m. Residents need to bring a current driver's license that matches the name on the utility bill.

Station #1 Crud Cruiser: The Crud Cruiser (large truck) has designated compartments for different types of hazardous waste that must be kept separate.

When the compartment for one type of hazardous waste is full (usually paint first), no more of those types of items can be accepted. Only the first 50 households will be guaranteed access to the Crud Cruiser. Typically the Crud Cruiser accommodates approximately 130 households before it reaches capacity.



Station #2 Electronics Recycling: You can dispose of e-waste items including CD/DVD drives, cell phones, computers (hard drives, monitors, laptops, and cables), printers, ink cartridges, and televisions. Anything with a battery or that plugs in is acceptable, including small appliances.

Station #3 Document Shredding: Bring paper to be shredded in a non-returnable container like a cardboard box or paper bag that can also be recycled.

Station #4 Bulk/Brush Trash: Drop off large bulk/brush trash.

Station #5 Tire Recycling: We will collect tires and help the Fire Department collect old fire extinguishers.

REMINDER: Doorside Household Hazardous Waste Pickup Available Year Round

Our garbage and recycling service provider, Community Waste Disposal, offers a Household Hazardous & Electronic Waste Door Side Collection program. Items accepted via the HH&EW Door Side Collection program include poison, solvent, oil-based and latex paint, aerosols, used motor oil, auto batteries, and fluorescent tubes. This service is provided on demand and is included in residents' regular monthly trash and recycling charge. For more information and to receive a collection kit, call CWD at 972.392.9300.

Chief Cantrell Provides Fire Update

At the January 18 City Council Worksession, Fire Chief Mark Cantrell provided a Fire Department update highlighting the department's impressive life-saving numbers, awards and recognitions, equipment upgrades, awarded grants, and personnel training.

Providing advanced medical care is at the heart of the fire department's mission and having 100% of operations personnel trained as paramedics is vital. In 2021, the department had an 88% save rate and a 54% save rate over the last four years; much higher than the national average of 23%. This past year the department was recognized as a Heart Safe Community (awarded to only 23 cities in the 19 county region), received the American Heart Association's Mission: Lifeline® EMS Silver Plus Achievement, and an EMS for Children award. Over the last year, the department has also provided COVID vaccinations to 3,100 individuals and provided vaccinations for home-bound residents unable to get out.

The department added equipment over the last few years to improve its assistance to the community. An increased emphasis on quality EMS care led the department to purchase transport ventilators, an enhanced cardiac monitor training simulator, and intubation trainers. Six new vehicles were added to the fleet, including a new fire engine with a whole new take on apparatus design. Engine 243 is nearly six feet shorter than other traditional engines allowing for a tighter turning radius and more maneuverability.



In the last few years, Colleyville Fire Department has been quite successful in actively obtaining grants. A SAFER grant for \$425,000 helped offset the cost of adding three additional personnel, \$262,000 in grant funds paid for 25 new air packs, and a \$62,000 grant purchased ten new handheld radios. The department also assisted other departments in obtaining grants; \$150,000 for the City Hall generator and \$38,000 for a Public Works emergency response trailer. Fire personnel have also been instrumental in several building projects including the Parks department office reconstruction, Hall Johnson Fire Facility reconstruction, apparatus bay upgrades at all three fire stations, exterior refurbishment at Stations 1 and 2, and a radio system upgrade at Station 3.

The last few years have been a period of tremendous growth for the Fire Department! We are so proud of the Fire Department's commitment to the safety and well-being of our Colleyville community.
